- 3) Sponsors must know the person(s) well enough to write a satisfactory recommendation.
- 4) The Admissions Committee shall investigate the applicant's character and fitness for membership and review the applications for membership with appropriate sponsors.
- 5) When applicants are accepted as members, sponsors must maintain contact with their sponsored members, providing them with guidance and information regarding the club. They should encourage them to participate in the club's activities and to become involved with various committees that help with the operation of the club.
